ORDINANCE NO. 110

AMENDMENT TO VILLAGE OF PERRINTON SEWER AND WATER ORDINANCES

AN ORDINANCE AMENDING THE ORDINANCES KNOWN AS "AN ORDINANCE TO PROVIDE FOR THE ISSUANCE OF SELF-LIQUIDATING WATER SYSTEM AND PLANT FOR THE VILLAGE OF PERRINTON, GRATIOT COUNTY, MICHIGAN, UNDER THE PROVISIONS OF ACT 94, PUBLIC ACTS OF MICHIGAN, 1933, AND ACTS AMENDATORY THERETO, AND TO PROVIDE FOR THE RATES TO BE CHARGED FOR SAID WATER SYSTEM AND PLANT AND FIX THE COLLECTION AND USE OF THE REVENUES OF SAID WATER SYSTEM AND PLANT AND PROVIDING FOR A STATUTORY LIEN ON THE REVENUE THEREON IN FAVOR OF THE HOLDERS OF SAID BONDS AND PROVIDING FOR THE OPERATION AND CONTROL OF SUCH WATER SYSTEM AND PLANT" AS AMENDED BY ORDINANCE NO. 108, THE ORIGINAL ORDINANCE HAVING BEEN ADOPTED ON JULY 19, 1950 AND THE AMENDING ORDINANCE HAVING BEEN ADOPTED ON JULY 5, 1977, AS WELL AS TO AMEND ORDINANCE NO. 105, ENTITLED PREAMPLE OF 107 AS AMENDED BY ORDINANCE NO. 107, ADOPTED JULY 5, 1977.

THE VILLAGE OF PERRINTON HEREBY ORDAINS:

CHAPTER I

SECTION I. Title. This ordinance shall be known and cited as "The Village of Perrinton combined sewage disposal system and water supply system ordinance" and shall be divided into Chapter 1, Chapter 2, Chapter 3, and Chapter 4.

SECTION II. The difinitions contained in this ordinance shall, except for those definitions specifically changed by this ordinance, remain those definitions as are set forth hereafter in Chapters 2 and 3.

SECTIONS III. It is hereby determined to be desirable and necessary for the public health, safety and welfare of the Village of Perrinton that existing water supply and sewage supply systems be combined into one system and that the joint system be operated on a public utility rate basis in accordance with the provisions of Act 94 of the Michigan Public Acts of 1033, as amended.

SECTION VI. Whenever the word "system" is referred to in this ordinance, it shall be understood to mean the following:

a. Those portions of the Gratiot County Sanitary Sewage Disposal System No. 3 (Perrinton Fulton) which lie within the boundaries of the Village of Perrinton, including all sewers, pumps, lift stations, treatment facilities and all other facilities used or useful in the collection, treatment, and disposal of domestic, commercial or industrial wastes including all appurtenances thereto and including all extensions and improvements thereto which may be hereafter acquired; and

b. The complete water supply system of the Village of Perrinton and all appurtenances thereto including all extensions improvements and additions thereto. Whenever the words "revenues" and "net revenues" are used in this ordinance, they shall be understood to have the meaning as defined in Section 3 of Act 94 of the Michigan Public Acts of 1933, as amended.

Whenever the words "Former Water Ordinance" are used in this ordinance they shall be understood to mean the provisions of Sections II through XI of the Village ordinance adopted on July 19, 1950, entitled "An ordinance to provide for the issuance of self-liquidating revenue bonds for the acquisition and construction of a water system and plant for the Village of Perrinton, Gratiot County, Michigan under the provisions of Act 94, Public Acts of Michigan, 1933, and Acts amendatory thereto, and to provide for the rates to be charged for said water system and plant and fix collection and use of the revenues of said water system and plant and providing for a statutory lien on the revenue thereon in favor of the holders of said bonds and providing for the operation and control of such water system and plant", as amended by ordinance No. 108, adopted on July 5, 1977.

Whenever the words "Former Sewer Ordinance" are used in this ordinance they shall be understood to mean the provisions of Section 3 through 15 of the Village ordinance entitled "Ordinance No. 108".

CHAPTER 2

SECTION I. Sections II through IX of the Former Water Ordinances shall be deemed to be all of the provisions of Chapter 2 of this ordinance and such provisions are by their reference incorporated herein in their entirety resulting in their consolidation into this ordinance.

SECTION II. The provisions of Section I of the Former Water Ordinance are hereby repealed.

CHAPTER 3

SECTION I. The provisions of Section I of the Fowmer Water Ordinance are hereby repealed.

CHAPTER. 3

SECTION I. The provisions of Sections 3 through 15 of the Former Sewer Ordinance shall be deemed all of the provisions of Chapter 3 of this ordinance and such provisions are by their reference incorporated herein in their entirety resulting in their consolidation into this ordinance.

SECTION II. The provisions of Sections 1 and 2 of the Former Sewer Ordinance are hereby repealed.

CHAPTER 4

SECTION I. All provisions of any Village ordinance inconsistent with the foregoing are repealed.

SECTION II. This ordinance shall be published once, in full in the <u>Gratiot County Herald</u>, a newspaper of general circulation within the boundaries of the Village and qualified under State law to publish legal notice, promptly after its adoption and shall be recorded in the ordinance book of the Village and such recording authenticated by the signatures of the Village President and the Village Clerk.

SECTION III. This ordinance shall become effective immediately upon its adoption.

Passed and approved by the Village Council of the Village of Perrinton, Michigan, in special session, held October 26, 1983.
