### VILLAGE OF PERRINTON Ordinance No. 125

### AN ORDINANCE TO TEMPORARILY AMEND THE ZONING OF THE PROPERTY LOCATED AT 113 S. ROBINSON STREET TO PROVIDE FOR TEMPORARY REZONING.

#### THE VILLAGE OF PERRINTON ORDAINS:

SECTION I - That the Village of Perrinton temporarily rezones the property at 113 S. Robinson Street, Perrinton, MI from B-1 Local Business District to R-2 Medium Density Residential for a period of six (6) months. During the time in which the property is zoned R-2 Medium Density Residential, no more than two (2) people may occupy the premises as a residence, and all other provisions relating to residential zones shall be applicable.

SECTION II - The period of R-2 Medium Density Residential zoning shall begin December 1, 2013 and shall terminate automatically on May 30, 2014. Upon automatic termination, the aforesaid property shall revert back to a zoning classification of B-1 Local Business District, subject to all provisions thereof, including the provisions as denying residential occupancy.

SECTION III - Validity. If any section or portion of this Ordinance is found for any reason to be invalid or otherwise void under law, judicial proceedings or otherwise, the aforesaid property shall immediately revert to B-1 Local Business District zoning.

SECTION IV - Non-Applicability of Other Ordinances. All ordinances and/or parts of ordinances inconsistent with this Ordinance are hereby declared inapplicable insofar as other ordinances may be applicable to aforesaid property to the extent necessary to give this Ordinance full force and effect.
